Likewise, the author of the argument against the measure may prepare and submit a rebuttal argument to the argument in favor of the measure or may authorize in writing any other person or persons to prepare, submit, or sign the rebuttal argument.

A rebuttal argument shall not be accepted unless accompanied by this completed form, which shall contain the printed name(s) and signature(s) of the person(s) submitting it or, if submitted on behalf of a bona fide association of citizens/organization, the name of the association/organization and the printed name and signature of at least one of its principal officers.

Word count limit for Rebuttal Arguments = 250

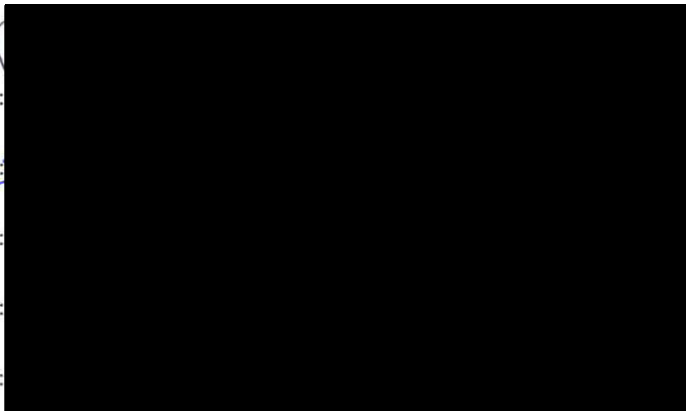

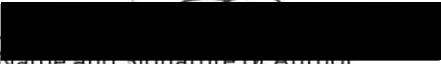

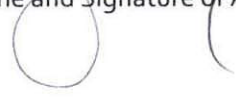

Rebuttal to Argument Against Measure X

Not only does the sole opponent of Measure X deliberately mislead voters with inaccurate, untruthful statements, the author lives in Morgan Hill and has submitted similar arguments against three other school districts.
