 This is contaminated landfill. The Amendment basically ignores the risks from earthquakes, liquefaction, and sea-level rise. Brisbane spoke clearly in 1994 when the people voted to ban housing on the Baylands for safety reasons.
 This ill-advised Amendment ignores the long-term liability issues, water scarcity, the recommended renewable energy plan, and legitimate citizen concerns that were voiced.
 This Amendment does not protect us from exposure to airborne contaminants, exhaust, /2 dust, vapors, and extensive pile driving, or poisons fouling groundwater and the Bay.
The current Amendment proposal was driven by fear and is a huge gamble. l 3
