29 10	April 8, 2013 April 27, 2013	Vote by Mail Ballot & Voter Information Pamphlet to be mailed between these dates. Replacement ballots may also be obtained in our office up to Election Day at 8 p.m. <i>EC §9094, 3001, 3023, 13303, 4041</i>
15	April 22, 2013	Voter Registration Closes on this date to be eligible to vote in this election. <i>EC §§2102, 2107</i>
11	April 26, 2013	County may begin processing of Vote by Mail Ballots on this date. Processing at this time includes opening vote by mail ballot return envelopes, removing ballots, duplicating any damaged ballots, and preparing the ballots to be machine read. Under no circumstances may a vote count be accessed or released until 8 p.m. on the day of the election. <i>EC §15101(b)</i>
0	May 7, 2013	Election Day - Voted mail ballots must be received by the Elections Office no later than 8 p.m. in order to be counted. <i>EC §§1500, 3017, 3020, 4103</i>
28	June 4, 2013	Last day for County to certify election results to district. <i>EC §15372</i>
