\$6,000,000 Bond Issue

When school boards ask voters' permission to go into debt with bonds like Measure C, 15
what are they saying? They are admitting that everything they spend our tax dollars on, 15
now, is more important than the projects in this Measure. 10

Budgets reflect priorities. 3

Bayshore Elementary School District is saying every education dollar spent today is 9
going to something they prioritize higher than "improv[ing] student access to...modern 12
technology." \

Do you agree? 3

Education Data Partnership (www.Ed-Data.K12.ca.us) shows only about 389 students in 10
Bayshore Elementary School District, so this bond could exceed \$15,400/student -- NOT 9
counting interest and administration expenses. 5

Would you buy a-computer with a useful life of 3-5 years, and pay for it with a 25- 19
**year loan? **

No? That's what the District is asking you to do. 10

Which is more important to you? 6

1. **Paying reasonable amounts for "modern technology" now, by using dollars** 11
already in schools' budgets. 4

2. **Sending new tax dollars -- through principal and interest payments -- to big** 12
banks, investment brokers, and others who buy these bonds as tax shelters. 12

If you value children's "access to computers" over funding tax shelters, vote NO on 14
Measure C. 2

If you value children having access to "modern technology" versus making principal 12
and interest payments for 25 years, vote NO on Measure C. 11

Likewise, the author of the argument against the measure may prepare and submit a rebuttal argument to the argument in favor of the measure or may authorize in writing any other person or persons to prepare, submit, or sign the rebuttal argument.

A rebuttal argument shall not be accepted unless accompanied by this completed form, which shall contain the printed name(s) and signature(s) of the person(s) submitting it or, if submitted on behalf of a bona fide association of citizens/organization, the name of the association/organization and the printed name and signature of at least one of its principal officers.

Word count limit for Rebuttal Arguments = 250

The rebuttal arguments shall be submitted to the elections official conducting the election no later than _____.

These rules apply to all rebuttal arguments unless a rebuttal argument is otherwise provided by law.
